BY-LAW NO. 1750

BEING A BY-LAW of the Municipal Corporation of the City of North Bay to close a portion of a street in the City of North Bay, said portion of a street being composed of part of Harriet Street as shown on a plan of subdivision registered in the Registry Office for the Registry Division of Nipissing as Plan No. 15.

WHEREAS The Municipal Council of the Corporation of the City of North Bay have been requested, and upon consideration, deem it advisable to close a portion of a street in the City of North Bay, said Portion of a Street being composed of part of Harriet Street, as shown on a plan of subdivision registered in the Registry Office for the Registry Division of Nipissing as Plan No. 15.

THEREFORE under and by virtue of the authority vested in the Council of the Municipal Corporation of the City of North Bay by the Municipal Act, being R.S.O. 1950, Chapter 243, THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. All and singular that certain parcel or tract of land and premises situate, lying and being in the City of North Bay, in the District of Nipissing and Province of Ontario, being composed of part of Harriet Street as shown on a plan of subdivision registered in the Registry Office for the Registry Division of Nipissing as Plan No.15 and which said parcel may be more particularly described as follows:

Commencing at the most southerly angle of Lot A as shown on the said plan, thence north-westerly along the south-westerly limit of the said Lot A and along the south-westerly limits of Lots 17,18,19, 20 and 21, of the said plan, in all a distance of 397.25 feet to the north-west limit of the said Lot 21; thence south-westerly along the south-westerly production of the north-westerly limit of the said Lot 21, 39.60 feet to the south-westerly limit of the said Lot 21, 39.60 feet to the south-westerly limit of the said Lot 21, 397.25 feet to the south-westerly production of the south-easterly limit of the said lot A; thence north-easterly in a straight line 39.60 feet more less to the said point of commencement, <u>IS HEREBY CLOSE AND STOPPED</u> <u>UP</u>.

The said parcel as herein described being further shown outlined in red on a plan prepared by E. L. Moore, Ontario Land Surveyor, dated at North Bay, Ontario, 8th February, 1955 and hereto attached.

THAT the Council of the Municipal Corporation in the City of North Bay shall hear in person or by his or her solicitor, counsel or agent, any person who claims that his or her lands will be prejudicially affected by this By-law and who applies to be heard.

THAT this By-law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.
