BEING A BY-LAW to regulate the closing of Barbers' Shops in the Town of North Bay.

WHEREAS an Application and Petition has been presented to the Municipal Corporation of the Town of North Bay for the passing of a By-Law regulating the closing of Barbers' Shops within the limits of the said Town.

AND WHEREAS it is deemed advisable by the said Municipal Corporation of the Town of North Bay that such a By-Law should be passed.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED BY THE MUNICIPAL CORPORATION OF THE TOWN OF NORTH BAY AS FOLLOWS :-

- THAT By-Laws Numbers 449, 480 and 587, be and the same are hereby repealed.
- 2. FROM and after the date of the passing of this By-Law all Barbers' Shops within the limits of the Town of North Bay, shall be closed as follows:-
  - Wednesday afternoons from twelve-thirty P.M. to five A.M. in the forenoon of the next following day on which such business can be legally carried on, during the months of May, June, July, August, September and October of each year.
  - (b) During the entire day of all Dominion and Civic Holidays.
  - Mondays, Wednesdays (except as provided in sub-section "A") and Fridays of each week throughout the year at seven P.M. until Five A.M. of the next following day on which such business can be legally carried on.
  - (d) Tuesdays and Thursdays of each week, throughout the year, at seven P.M. until the hour of Five A.M. on the next following day on which such business can be legally carried on.
  - (e) Saturday night of each week at Ten P.M. until Five A.M. on the next following day on which such business can be legally carried on.
- 3. NOTWITHSTANDING anything contained in the preceding Paragraph and sub-sections thereof all Barbers' Shops within the limits of the said Town may remain open until the hour of Ten o'clock of any evening preceding a Legal Holiday, Dominion or Civic.
- Barber Shop within the limits of the said Town, to be served between the hours hereinbefore specified, and the owner, occupier or other person in charge of each such shop shall close, and keep such shop closed within the hours hereinbefore provided.

By-law 161

ANY PERSON convicted of a breach of any of the provisions of this By-Law shall forfeit and pay, at the discretion of the convicting Magistrate, a penalty not exceeding, exclusive of costs, the sum of Fifty Dollars (\$50.00) for each offence, and in default of payment of the said penalty and costs forthwith, the said penalty and costs, or costs only, may be levied by distress and sale of the goods and chattels of the offender, and in case of there being no distress found out of which such penalty can be levied, the convicting Magistrate may commit the offender to the Common Gaol of the Town of North Bay with or without hard labour, for any period not exceeding six calendar months, unless the said penalty and costs, if any, including the cost of the said distress and of the committal and conveyance of the offender to the said Gaol, are sooner paid.

6. This By-Law is passed in accordance with the provisions of the Revised Statutes of Ontario, 1914, Chapter 229, Section 84 and Amendments thereto, particularly the Amendments contained in 11 George V. 1921, Chapter 76, Section 6, and pursuant to the Petition presented in accordance therewith.

THIS BY-LAW shall take effect immediately after the passing thereof.
