BY-LAW NUMBER 772.

BEING A BY/LAW to authorize the construction of two septic tanks on certain Streets in the Town of North Bay as set out in Schedule "A" hereto attached, and which forms part of this By-Law, as a Local Improvement under the provisions of the Local Improvement Act.

AND WHEREAS it is expedient that the construction of the work hereinafter described shall be undertaken as a Local Improvement, and notice of the intention of the Council to undertake said work has been published.

AnD WHEREAS the Provincial Board of Health has recommended the construction of the said septic tanks as an outlet to sewers draining into them on said Streets as set out in Schedule "A" hereto attached, and it is therefore necessary and desirable in public interest and on sanitary grounds to construct said septic tanks according to the said recommendation as a Local Improvement.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF NORTH BAY ENACTS AS FOLLOWS:

THAT it is determined and declared, this By-Law being passed by a vote of two-thirds of all the members of the Council, that it is necessary and desirable that the construction of certain septic tanks in the Town of North Bay, as set out in Schedule "A" hereto attached and which forms part of this By-Law, should be undertaken as a Local Improvement under the provisions of the Local Improvement Act.

THAT as above determined and declared the said septic tanks be constructed as set out in Schedule "A" above referred to as a Local Improvement under the provisions of the Local Improvement Act.

THAT the Engineer of the Corporation do forthwith make such Plans, profiles and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.

THE work shall be carried on and executed under the superintendence and according to the directions of such Engineer.

The Mayor and Clerk are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of this Council, to be declared by resolution.

The Treasurer may, subject to the approval of the Council, agree with any Bank or person for temporary advances of money to meet the cost of the work, pending the completion of it.

The Special Assessment shall be paid by 20 equal annual instalments.

The Debentures to be issued for the loan to be effected to pay for the cost of the work when completed shall bear interest at 5½% per cent per annum, and shall be payable within 20 years on the instalment Plan.

ANY Person whose lot is specially assessed may commute for a payment in cash the special rates imposed thereon, by paying the portion of the cost of construction assessed upon such lot without the interest, forthwith after the special assessment roll has been certified by the Clerk.
