

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 79-68


BEING A BY-LAW TO SUBMIT TO A VOTE OF THE MUNICIPAL ELECTORS OF THE CITY OF NORTH BAY, FOR THEIR ASSENT, A PROPOSED BY-LAW AUTHORIZING THE CORPORATION OF THE CITY OF NORTH BAY TO ENTER INTO AN EXCLUSIVE FRANCHISE AGREEMENT WITH CHARTERWAYS LIMITED, GRANTING TO THE SAID COMPANY THE EXCLUSIVE RIGHT TO MAINTAIN AND OPERATE BUSES FOR THE CONVEYANCE OF PASSENGERS WITHIN THE TERRITORIAL LIMITS OF THE CITY OF NORTH BAY FOR A PERIOD OF TEN (10) YEARS, COMMENCING ON THE 1ST DAY OF JANUARY, 1969, UPON AND SUBJECT TO THE TERMS AND CONDITIONS SET FORTH IN THE EXCLUSIVE FRANCHISE AGREEMENT, BEING SCHEDULE "A" ATTACHED TO AND FORMING PART OF THE PROPOSED BY-LAW.

The Council of the Corporation of the City of North Bay, pursuant to The Municipal Franchises Act, R.S.O. 1960, c. 255, Sec. 3 (1) and the applicable provisions of The Municipal Act, R.S.O. 1960, c. 240, as amended, hereby enacts as follows:

1. That the Proposed By-law authorizing the Corporation of the City of North Bay to enter into an exclusive Franchise Agreement with Charterways Limited, granting to the said Company the exclusive right to maintain and operate buses for the conveyance of passengers within the territorial limits of the City of North Bay for a period of ten (10) years, commencing on the 1st day of January, 1969, upon and subject to the terms and conditions set forth in the exclusive Franchise Agreement, being Schedule "A" attached to and forming part of the said proposed By-law be submitted to a Vote of the Municipal Electors of the City of North Bay for their assent.
2. That the Ballot Paper for voting on the Proposed By-law be in accordance with Form 25 of The Municipal Act and shall include the following:

"Voting on a Proposed By-law to grant to Charterways Limited an exclusive Franchise to operate passenger buses in the City of North Bay for a period of ten (10) years, commencing January 1st, 1969, submitted by the Council of The Corporation of the City of North Bay."
