BY-LAW NO. 2005-139

**BEING A BY-LAW TO AUTHORIZE THE UPGRADES AND REPAIRS
TO THE WASTE WATER (SEWAGE) TREATMENT PLANT
FACILITIES AND SANITARY SEWER LIFT STATION**

WHEREAS the *Municipal Act, 2001* (S.O. 2001, c-25), Section 326 authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the *Municipal Act, 2001* (S.O. 2001, c-25), Section 401 authorizes the Council to pass a by-law for the purposes herein stated;

AND WHEREAS the Council passed Resolution 2005-418 at its meeting held June 6, 2005, authorizing the expenditure of funds for the upgrades and repairs to the Waste Water (Sewage) Treatment Plant Facilities and the Sanitary Sewer Lift Station, with a net debenture cost of \$280,000.00;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS;

1. That the expenditure of \$280,000.00 for the upgrades and repairs to the Waste Water (Sewage) Treatment Plant Facilities (WWTP) and the Sanitary Sewer Lift Station for the following be hereby authorized:

SCADA upgrades at WWTP	\$ 75,000.00
Replacement and reinstallation of West Ferris well pumps at WWTP	30,000.00
Gas train repairs and annual inspection	30,000.00
New chlorine gas regulators and eductors	35,000.00
Mixer pump installation at raw sewage well at Main Plant	38,000.00
Overhaul of grinder at Marshall Street Pump Station	27,000.00
Repairs to WWTP roof	25,000.00
Rewinding of both return activated sludge pumps to increase inverter rating	9,000.00
Financing Costs	<u>11,000.00</u>
Net Amount to be Debentured	\$ 280,000.00

2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of work as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount of \$280,000.00 limited in this by-law.
3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
4. That the cost of the works be funded first from the water rates, and if required the balance be funded by debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years and shall be a charge against all rateable property in the Urban Service Area of The Corporation of the City of North Bay, to such an extent as to repay the principal and interest on a principal amount not to exceed \$280,000.00.

READ A SECOND TIME IN OPEN COUNCIL THIS 20TH DAY OF JUNE, 2005.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 20TH DAY OF JUNE, 2005.
