

BY-LAW NUMBER 828

BEING a By-law to amend Construction By-law number Six Hundred and Eighty-five (685) of the City of North Bay.

WHEREAS By-law Number Six Hundred and Eighty-five (685) provides for the construction, amongst other works, of a sewer through lot number Two Hundred and Twenty-three (223) along McIntyre Street, between Fraser Street and Ferguson Street a distance of One Hundred and Twenty- (120') feet.

AND WHEREAS it was found expedient to build the said sewer only a distance of One Hundred and Nine feet (109') on McIntyre Street.

AND WHEREAS By-law number 685 provides for the construction, amongst other works, of a sewer on Hardy Street from Regina to John Street.

AND WHEREAS it was found expedient to build such sewer only from John Street westerly on Hardy Street to a lane.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY, ENACTS AS FOLLOWS:-

1. That Clause One of Schedule "A" of Construction By-law Number Six Hundred and Eighty-five (685) be amended to read as follows:-

"Through Lot Number Two Hundred and Twenty-Three (223) along McIntyre Street between Fraser Street and Ferguson Street, for a distance of One Hundred and Nine Feet".

2. That Clause Two of Schedule "A" of Construction By-law Number Six Hundred and Eighty-Five (685) be amended to read as follows:-

"On Hardy Street from John Street (formerly Brookes Street ) westerly along Hardy Street to a lane west of Maher Street to accommodate lot numbers 99 and 100 Regina Street".

This By-law shall take effect on the day of the final passing thereof.
