

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 77-75

BEING A BY-LAW TO AMEND BY-LAW NO. 2054,
BEING A BY-LAW TO REGULATE THE PROCEEDINGS
OF COUNCIL OF THE CORPORATION OF THE CITY
OF NORTH BAY.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Section 48 of By-law 2054 be amended to provide that the vote of the Council shall be by a recorded vote so that the said Section shall now read as follows:

48. "If the motion for reconsideration be made at the same meeting, the question shall not be considered unless a majority of the members of the Council present vote therefor, and such vote shall be by a recorded vote and if the motion for reconsideration be made at the next meeting, the question shall not be considered unless a majority of the whole of Council vote therefor, and such vote shall be by a recorded vote. No question shall be reconsidered more than once nor shall a vote to reconsider be reconsidered."
2. That Clause B of Section 127 of By-law No. 2054 be and is hereby deleted.
3. This By-law shall take effect upon the final passing thereof.

4. That Section 16, Sub-section 1 of By-law No. 1896 be amended to read as follows:


SECTION SIXTEEN - Restricted Parking

- 1. (a) Municipal Officials and Police Vehicles - An authorized municipal official and vehicles of the North Bay Police Department in that area set out on both sides of McIntyre Street opposite City Hall at any time, daily, Monday to Saturday inclusive.
- (b) Police Vehicles of North Bay Police Department in that area on the south side of Fraser Street in the front of the Provincial Court Offices at 581 Fraser Street any time, daily, Monday to Saturday inclusive.

READ A SECOND TIME IN OPEN COUNCIL THIS 30TH DAY OF JUNE, 1975.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 30TH DAY OF JUNE, 1975.
