**BY-LAW NO. 28-98**

**BEING A BY-LAW TO AMEND THE SNOW  
MACHINES BY-LAW TO ALLOW A DEFINED  
ACCESS ROUTE TO THE DOWNTOWN**

WHEREAS the Snowmobile By-law No. 11-95 prohibits snow machines in the Urban Area of North Bay;

AND WHEREAS it is deemed desirable to define an access route from the Government Dock on Lake Nipissing to the Downtown for access on a trial basis.


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. Section 5(2) of By-law No. 11-95 is hereby amended to add after the word "sidewalk" the following: "except as listed in Schedule "D"."
2. Schedule "A" (Urban Area) of By-law No. 11-95 is hereby deleted and the attached Schedule "A" inserted in lieu thereof.
3. Schedule "B" (Parklands) of By-law No. 11-95 is hereby amended by adding the following:  
"Waterfront Park: From the Government Dock to the easterly side of Memorial Drive thence westerly to the CP mainline."
4. The attached Schedule "D" is hereby added as Schedule "D" to By-law No. 11-95.

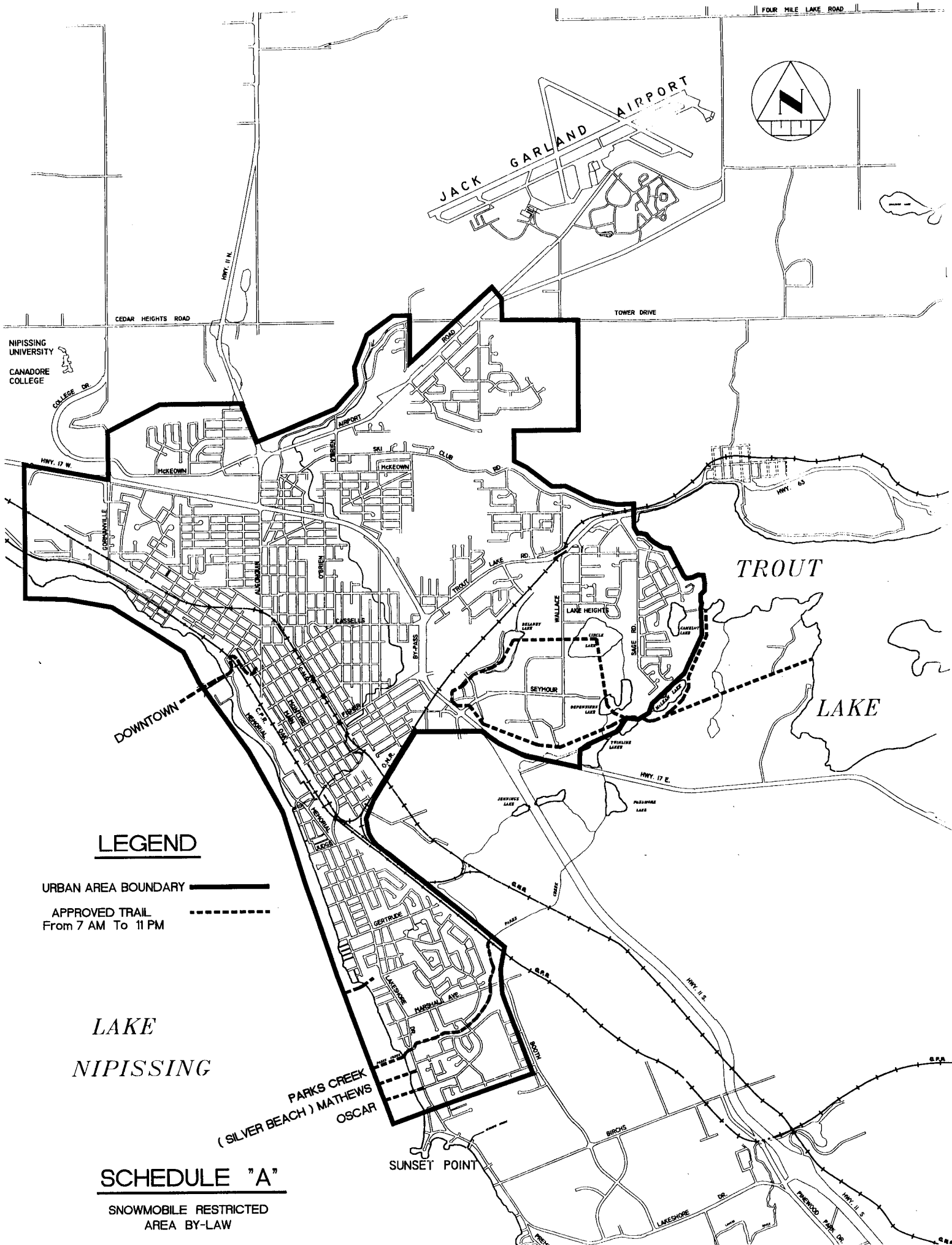
