**TERMS AND CONDITIONS**

**1. Registration**

All users of the landfill site must complete this application form and return it to the Weigh Scale Operator or to City Hall in order to obtain landfill site user privileges and to set up an approved charge account.

**2. Method of Payment**

**Business**

Invoices will be issued to the disposal hauler at the landfill site after dumping. Statements will be sent on a monthly basis. Payment is due 30 days after date of statement. Failure to comply with By-law 2010-108 respecting the disposal of waste at the landfill site may subject you to penalties as set out in Section 10 of By-law 2010-108. A deposit of \$500.00 is required and must be received either by cheque or cash before being granted landfill privileges.

**Private**

Private users who reside outside of the corporate limits of North Bay will be invoiced an annual fee of \$50.00 to permit annual access to the Merrick Landfill site for waste disposal privileges. This rate approximately equates to the taxes a resident of North Bay pays for the same privileges.

3. **References**

A minimum of one full year of good credit history is required to be considered for a Landfill Charge Account. A minimum of 3 credit references must be provided on the Customer Credit Application provided in this package.

4. **Vehicle Information**

All users must include a list of all vehicles which will be hauling waste to the landfill site. Include an identification number, licence plate number, and a tare weight for each vehicle with a capacity to carry 1 (one) tonne or more with this application. I.D. no., if applicable, must be in a place on the vehicle so it is visible to the scale house operator at the landfill site.
