**DOOR-TO-DOOR SALES/SERVICE PERSON**

<b>Applicable to:</b>	Every person that goes from place to place selling or offering for sale a service of any kind.
<b>Definitions:</b>	A Person who goes from place to place selling or offering for sale a service of any kind.
<b>Exemptions:</b>	None
<b>Annual Licence Fee:</b>	\$200.00 per year
<b>Licence Circulated to:</b>	1. North Bay Police Service
<b>Special Conditions:</b>	<ol style="list-style-type: none"> <li>1. Every Door-to-Door Sales/Service Person shall produce to the Issuer of Licences at the time of application, two pieces of identification, one of which shall be photographic identification. Such identification shall clearly state the applicant's name and current residential address.</li> <li>2. Every Door-to-Door Sales/Services Person shall produce to the Issuer of Licenses at the time of application, a letter from their employer authorizing them to conduct business on behalf of the employer. This letter shall include the name of the business, current business address of the business together with the name of a contact person for complaint purposes.</li> <li>3. No Person shall engage in, or carry on his business by passing door-to-door within the City before 9:00 a.m. any day or after 7:00 p.m. any day.</li> <li>4. Every Door-to-Door Sales/Service Person shall provide a current Criminal Record check for all owners, operators and employees who are eighteen (18) years of age or over, which shall be obtained by them at their own expense from the North Bay Police Service or the local Police Service where they reside.</li> <li>5. Each Licence shall be issued for the period of time that the Door-to-Door Sales/Service Person is selling his or her service within the City. The Door-to-Door Sales/Service Person will require a new Licence each time they attend within the City to sell their service.</li> <li>6. Every Door-to-Door Sales/Service Person will produce to any homeowner a copy of the Licence that they have been provided by the City at the request of the homeowner.</li> </ol>
