**HAWKER AND PEDDLER**

<b>Applicable to:</b>	<p>Hawker and Peddler shall mean any Person who:</p> <ol style="list-style-type: none"> <li>1. Goes from door to door with goods, wares or merchandise for sale or who carries and displays samples, patterns or specimens of any goods, wares or merchandise for which immediate sales are made and for which orders are taken with delivery to follow.</li> <li>2. Sells from a permanent structure on a temporary basis, goods, wares or merchandise for sale, or who carries and displays samples, patterns or specimens of any goods, wares or merchandise for which immediate sales are made and for which orders are taken with delivery to follow.</li> <li>3. Is engaged in retail sales but does not have a commercial store front and includes their employees but does not include:             <ol style="list-style-type: none"> <li>(i) Service Clubs</li> <li>(ii) Not for Profit Clubs</li> <li>(iii) Charitable Organizations or</li> <li>(iv) Such other institutions, organizations or clubs as the Council by Resolution may approve.</li> </ol> </li> </ol>
<b>Definitions:</b>	<p><u>Class A:</u> Class A Licence shall mean a Licence issued to a Resident.</p> <p style="padding-left: 40px;">Resident shall mean a Person who resides in the City and does not have a Place of Business in the City in which the Business is normally carried on and shall include a person who conducts Business in a place, premises or location on a one-time or temporary basis.</p> <p><u>Class B:</u> Class B Licence shall mean a Licence issued to a Non-Resident</p> <p style="padding-left: 40px;">Non-Resident shall mean a Person who has not resided continuously in the City for at least three (3) months immediately preceding the time of commencing a Business in the City.</p> <p><u>Class C:</u> Class C Licence shall mean an annual Hawker and Peddler Licence issued to the owner of the premises, in lieu of requiring individual persons to obtain Hawker and Peddler Licences to operate a Business on that premises.</p>
<b>Exemptions:</b>	<p>The requirement to obtain a Hawker and Peddler Licence does not apply to:</p> <ol style="list-style-type: none"> <li>1. The sale of goods by wholesale.</li> <li>2. Persons who sell goods that are grown or produced on their own agricultural operation within the City, or family members or employees who have written authority to sell the goods on their behalf.</li> <li>3. Persons who sell Christmas trees on a seasonal basis.</li> <li>4. Persons who conduct Business on a premises for which the Owner holds a valid Class C Licence.</li> </ol>
<b>Licence Fee:</b>	<p>Class A: \$100.00 per year (Resident) Licences shall run from January 1<sup>st</sup> to December 31<sup>st</sup> of each calendar year.</p> <p>Class B: \$300.00 per year (Non-Resident) Licences shall run from July 1<sup>st</sup> to June 30<sup>th</sup> of the next calendar year.</p> <p>Class C: \$3,000.00 per year (Annual) Licence shall run from January 1<sup>st</sup> to December 31<sup>st</sup> of each calendar year.</p>
