**PLACE OF AMUSEMENT - (Pool Tables, Bowling Alleys, Arcades)**

<b>Applicable to:</b>	Any Premises defined as a Place of Amusement.
<b>Definitions:</b>	<p>"Place of Amusement" shall mean a Business or Premises in which are offered facilities for the playing of:</p> <ul style="list-style-type: none"> <li>(i) three or more games of chance, or</li> <li>(ii) three or more games of mixed chance and skill, or</li> <li>(iii) a combination of three or more games of chance and games of mixed chance and skill.</li> </ul> <p>Games shall mean games that are not contrary to the <i>Criminal Code of Canada</i>, and shall include, but are not limited to video games, pinball games, table top hockey games, table top soccer games, electronic games, and billiard tables, pool tables or bagatelle tables or bowling alleys.</p>
<b>Exemptions:</b>	<ul style="list-style-type: none"> <li>1. Those with less than a total of three (3) games, machines and/or tables.</li> <li>2. Bingo halls where electronic equipment is used for the purposes of conducting Bingo games.</li> </ul>
<b>Annual Licence Fee:</b>	\$100.00 per year
<b>Application Circulated to and Approval Required From:</b>	<ul style="list-style-type: none"> <li>1. City of North Bay Fire Prevention</li> <li>2. City of North Bay Zoning Department</li> <li>3. City of North Bay Building Department</li> <li>4. North Bay Parry Sound District Health Unit</li> </ul>
<b>Special Conditions:</b>	<p>The Licensee shall ensure that:</p> <ul style="list-style-type: none"> <li>1. Orderly conduct is maintained in the Place of Amusement.</li> <li>2. The operation of the Place of Amusement shall be conducted in a manner that is not in any way adverse to the public interest.</li> <li>3. Every part of the Place of Amusement is sufficiently lighted so as to permit the safe use of the facility by the public.</li> <li>4. Waste receptacles are accessible to the users.</li> </ul>
