## BY-LAW NUMBER 680.



BEING a By-law to change the names of certain streets, and parts of streets in the Town of North Bay.

WHEREAS under the Provisions of Consolidated Municipal Act, 12-13 George V. 1922, Chapter 72, Section 400, Sub-section 38, Municipal Councils of Urban Municipalities are authorized to pass a By-law with the approval of the Judge of the District Court, and by a vote of three-fourths of all the members of the Council, changing the name of the high-way within the Municipality.

AND WHEREAS it is desirable that the said changes be made for the following reasons:-

- (1) To avoid confusion on account of some of the streets being named the same.
- (2) It would be more convenient that the change should be made.
- (3) Some of the streets are a continuation of other streets.

BE IT ENACTED, AND IT IS THEREFORE ENACTED BY THE MUNICIPAL COUNCIL OF THE TOWN OF NORTH BAY, AS FOLLOWS:-

(1) That the following streets be changed and new names substituted therefore, namely:-
