

BEING A BY-LAW to regulate the use of Bicycles within the Corporation of the City of North Bay.


WHEREAS it is deemed advisable to require all residents of the Municipality of the City of North Bay owning and using Bicycles within the said Municipality to obtain a license therefore, and to regulate the use of Bicycles upon the streets of North Bay.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. All residents of the City of North Bay using any bicycles shall on or before the 20th day of January in each year or before using any bicycle upon any street or highway of the Corporation obtain a license authorizing the use of said bicycles.
2. The annual fee for such license shall be the sum of fifty cents and shall be paid to the City Treasurer before the issue of such license and all licenses shall expire on the 31st day of December in the year that said license is issued.
3. The applicant for such license shall produce for examination by the Chief Constable or by Constables selected by said Chief Constable the bicycle in respect for which a license is applied.
4. No license shall be issued for the use of a bicycle the serial number of which has been obliterated or deface unless or until, in lieu of such serial number, a number has been stamped or impressed on said bicycle under the direction of the Chief Constable, and no bicycle shall be used unless the same bears a serial number or a number impressed thereon as aforesaid.
5. Each license shall be numbered and shall specify the name and address of the holder thereof, also the serial number or other number of the bicycle in respect of which the same has been issued and shall be signed by the Chief Constable or by the Constables selected by the Chief Constable.
6. Every holder of a license shall carry the same while using a bicycle on any highway within the City of North Bay, and shall upon request of any police officer produce the same for inspection and shall also permit the examination of any bicycle in his possession.
7. Every holder of a license shall be furnished, without charge, with a metal plate having stamped thereon the word "North Bay" and a number corresponding with his license and the year of the issue of such license.
8. Each holder of a license shall keep said metal plate attached in rear of bicycle in respect of which the same is issued and immediately below the saddle of the seat, and said plate shall at all times be kept visible from the rear.
9. No person shall remove or deface the metal license plate furnished under Section 7 thereof.
10. Every holder of a license shall notify the Chief Constable of full particulars of any change of address or of any sale, transfer or exchange or other disposition of the bicycle in respect of which such license has been issued. Such notice shall be given to the Chief Constable in writing within six days.
11. Every person guilty of a Breach of any Provisions of this By-Law shall be subject to a penalty on conviction thereof in the discretion of the convicting Magistrate of not more than five dollars exclusive of costs and all such penalties shall be recoverable under the Ontario Summary Conviction Act.
12. By-Law No. 1202 and all other By-Laws inconsistent with this By-Law are hereby repealed.

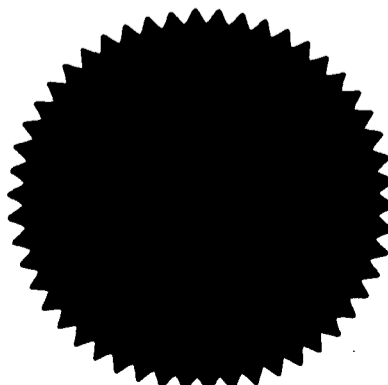
