

BY-LAW NO. 1449

BEING a By-Law to amend By-Law 1202, a By-Law to License residents owning and using bicycles on the Highway.

THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT Paragraph 6 of By-Law 1202 be repealed and the following substituted therefore;

"6. The annual fee for each such license shall be fifty cents (50¢) which shall be paid to the Treasurer by the person obtaining the license at the time the license is issued."

2. This By-Law shall go into effect immediately upon receiving approval of the Ontario Municipal Board.

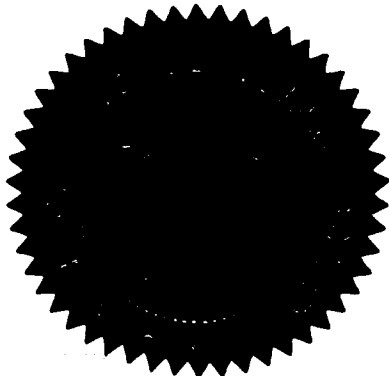
