## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 2007-197

BEING A BY-LAW TO AUTHORIZE THE SALE OF LANDS TO 2148197 ONTARIO INC. (Birch's Road – Parcel 1-6, Section 36M-540 – Niroc Construction Ltd.)

WHEREAS an Agreement of Purchase and Sale with 2148197 Ontario Inc. for the sale of vacant city owned land was approved by Resolution No. 2007-55 passed on the 7<sup>th</sup> day of August, 2007, after an open, competitive process;

AND WHEREAS the Municipality is authorized by Section 268 of the *Municipal Act,* 2001, to dispose of lands no longer required for municipal purposes;

AND WHEREAS Council deems it desirable to convey Parcel 1-6, Section 36M-540, to 2148197 Ontario Inc.

- The Corporation of the City of North Bay enter into an agreement with 2148197
  Ontario Inc. dated the 30<sup>th</sup> day of August, 2007 relating to the sale of vacant city owned land described as Parcel 1-6, Section 36M-540, Part of Block 1, Plan M-540, Parts 1 and 2, Plan 36R-8828, City of North Bay, District of Nipissing.
- The Corporation of the City of North Bay is hereby authorized and directed to transfer Parcel 1-6, Section 36M-540, Part of Block 1, Plan M-540, Parts 1 and 2, Plan 36R-8828, City of North Bay, District of Nipissing to 2148197 Ontario Inc.
- 3. The Chief Administrative Officer, and the Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain agreement between The Corporation of the City of North Bay and 2148197 Ontario Inc. and to affix thereto the corporate seal, and the City Solicitor is hereby authorized to execute such further and other documents as may be reasonably required to complete the transaction. The City Solicitor has the authority to electronically sign for completeness and release any document required to be registered on title electronically.
