Government's proposed Climate Change Action Plan (CCAP), which is anticipated to be released in June. The CCAP details the actions that the Ontario Government will take to achieve its emission reduction targets to 15 per cent below 1990 levels by 2020, 37 per cent by 2030 and 80 per cent by 2050;

And Whereas the City of North Bay has long encouraged the Province of Ontario to expand the use of Natural Gas outside the Urban centers to provide an affordable heating option for the Citizens of Rural and Northern Ontario;

And Whereas the Globe and Mail article talks to the proposed plan which was a commitment to eliminate the use of natural gas for home heating in newly built homes by 2030 and all others by 2050. This policy would force homeowners to move to more expensive forms of energy such as electricity.

Therefore Be It Resolved that the City of North Bay ask the Premier Kathleen Wynne, the Hon. Glenn Murray, Minister of Environment and Climate Change and the Hon. Bob Chiarelli, the Minister of Energy to consult with Municipalities of Northern Ontario on the impacts of this direction.
