BY-LAW NO. 1664

BEING A BY-LAW to amend By-law No. 1198, as amended by By-law No. 1242.

WHEREAS By-law No. 1198 is a By-law to provide for the licensing and regulating of dogs.

AND WHEREAS it is deemed advisable by the Municipal Council of the City of North Bay to amend the said By-law No. 1198.

THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That Clause No. 4(1) of By-law No. 1198 is hereby repealed and the following substituted therefor:

4(1) The owner of every dog or dogs shall annually, on or before the First day of May in each year, or so soon thereafter as the dog or dogs shall attain the age of six months, cause the same to be registered, numbered and described and licensed in the office of the City Clerk, and shall cause such dog to wear round his neck a collar to which there shall be attached a metallic plate having the words "North Bay Dog Tag" stamped thereon and the figures indicating the year for which the said license is paid and the number corresponding with the number under which the said dog is registered and the owner shall pay for such license and metallic plate as follows: for a male dog, if only one kept, \$4.00; for each additional male dog \$6.00: for a fomale dog, if only one kept, \$6.00; for each additional female dog \$9.00: for female spayed dogs where a certificate in writing by a licensed Veterinary Surgeon is produced the same license and rates will apply as for that of a male dog: Boarding Kennels \$20.00 annually.

2. That Clause No. 10 of By-law No. 1198, as amended by By-law No. 1242, is hereby repealed and the following substituted therefor:

10. Any duly authorized person may capture any dog found running at large contrary to the provisions of this By-law and may deliver such dog to the keeper of the dog pound for the City of North Bay, who shall impound the same, and the owner of such dog may be permitted to redeem the same (within four full days if the dog is wearing a tag of the current-year and within fortyeight hours if the dog is not wearing such tag) from the time of capture by paying for the use of the City Pound at the rate of \$1.50 per day which shall be paid to the Pound Keeper before such dog the owner shall obtain from the City Clerk a tag for any such dog that is caught and not wearing a tag or wearing a tag which is not for the then ensuing year or produce satisfactory evidence that a proper tag was purchased. The fee to be paid for such tag shall be the same as set out in Clause No. 4(1) of By-law No. 1198 as amended above. All dogs impounded under the provisions of this By-law if not redeemed (within four full days if the dog is wearing a tag of the current year and within forty-eight hours if the dog is not wearing such tag) after such impounding may be sold at the price which would have been paid for securing a tag for such dog, or at such higher price as the said pound keeper may think proper, and the purchaser before taking such dog from the pound shall purchase a tag from the City Clerk as is required by Clause No. 4(1) of By-law No. 1198. All dogs not so redeemed or sold shall (after the specified time above mentioned) be killed in such humane manner as the pound keeper may approve.
