BEING A BY-LAW TO AUTHORIZE THE EXCHANGE OF LANDS WITH CANARINO (WALKWAY BETWEEN NO'TTINGHAM DRIVE & THE TRANSCANADA PIPELINE)

WHEREAS Mario Canarino owns Parts 3 & 4, Plan 36R-10773 being Part of Parcel 27-1, Section 36M-56 1, in the City of North Bay, District of Nipissing;

AND WHEREAS The Corporation of the City of North Bay owns Part 1, Plan 36R-10773 being Part of Parcel Block 46, Section 36M-561, in the City of North Bay, District of Nipissing;

AND WHEREAS the said Part 1, Plan 36R-10773 has been declared surplus to the City and the City is authorized by Section 193 of the *Municipal Act*, R.S.O. 1990, Chapter M.45, to dispose of surplus lands as no longer required for municipal purposes;

AND WHEREAS Council deems it desirable to convey Part 1, Plan 36R-10773 being Part of Parcel Block 46, Section 36M-561 to the abutting owner, Carmine Canarino;

AND WHEREAS this exchange of lands is being made to recognize the actual location of the walkway between Nottingham Drive and the TransCanada Pipeline.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The Corporation of the City of North Bay is hereby authorized and directed to purchase Part 3 & 4, Plan 36R-10773 being Part of Parcel 27-1, Section 36M-561, in the City of North Bay, from Mario Canarino for the sum of \$2.00 therefore.
- The Corporation of the City of North Bay is hereby authorized and directed to sell Part 1, 36R-10773 being Part of Parcel Block 46, Section 36M-561, in the City of North Bay, to Carmine Canarino for the sum of \$2.00.
- 3. The Mayor, Chief Administrative Officer, City Clerk and City Solicitor are hereby authorized and directed to execute such documents as may be reasonably required to give effect to this exchange of land.
- 4. This By-Law comes into effect upon being passed.
