## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 2213

Being a by-law granting leave of absence to Chief Constable John W. Pilgrim by reason of illness;

And being a by-law granting to Chief Constable John W. Pilgrim an annual retirement allowance during his life to take effect immediately following the expiration of the leave of absence aforesaid.

WHEREAS under the Municipal Act, R.S.O. 1960, Chapter 249, Section 240 a Council may grant an annual retirement allowance to an employee during his life who has had continuous service for at least 20 years with the Municipality, upon and subject to the terms and conditions set forth in the said Section. 240.

AND WHEREAS Chief Constable John W. Pilgrim has had 36 years of continuous service with the Police Department of the City of North Bay and by reason of illness is incapable of efficiently discharging his duties.

AND WHEREAS by reason of the foregoing and by reason of the excellent services rendered by the said Chief Constable during his many years of service as aforesaid the Council of the Corporation of the City of North Bay is unanimously of the opinion that commencing August 1st 1965 Chief Constable John W. Pilgrim be granted leave of absence on full salary to continue until such time as his accumulated sick leave has been exhausted and that commencing immediately thereafter he be granted an annual retirement allowance as provided in this by-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That commencing August 1st 1965 Chief Constable John W. Pilgrim, by reason of illness, be granted leave of absence on full salary, the same to continue until such time as his accumulated sick leave has been exhausted.
- 2. That commencing immediately after the expiration of the period referred to in paragraph 1 of this by-law the said Chief Constable John W. Pilgrim be granted an annual retirement allowance during his life which together with the amount of any pension payments payable to the said Chief Constable under any Pension Plans of the Corporation of the City of North Bay shall amount to but not exceed the sum of Three Hundred Dollars (\$300.00) per month.
- 3. That the aforesaid annual retirement allowance be paid in monthly instalments commencing one month following the expiration of the leave of absnece aforesaid.
