THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2004-45

BEING A BY-LAW TO DESIGNATE A REDUCED LOAD PERIOD WITHIN RURAL ROADS IN THE CITY OF NORTH BAY.

WHEREAS Section 122 of the *Highway Traffic Act* enables the Municipality to pass a by-law to designate a reduced load period and the Highways or portions thereof to which the designation applies;

AND WHEREAS on February 23, 2004 the Council passed Resolution No. 2004-132 to impose half load limits on certain rural roads in the City;

AND WHEREAS notice of the passing of this by-law was given in the local newspaper on February 21, 2004 and signage will be posted accordingly;

AND WHEREAS this by-law does not apply to prevent direct access to established aggregate sources.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Pursuant to Section 122 of the *Highway Traffic Act* the roads set out on Schedule "A" hereto are hereby designated for reduced loads from March 1st, 2004 to and including May 15th, 2004.
- 2. This by-law shall not apply to the roads set out on Schedule "B" hereto.
- 3. This by-law shall come into force and effect upon being passed.

READ A FIRST TIME IN OPEN COUNCIL THE 8TH DAY OF MARCH, 2004.

READ A SECOND TIME IN OPEN COUNCIL THE 8TH DAY OF MARCH, 2004.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 8TH DAY OF MARCH, 2004.



SCHEDULE "A"

All roadways (except those noted in Schedule "B") to the north of a line formed by a projection of the south property limits of Cedar Heights Road and Tower Drive from the westerly corporate limit easterly to Lees Road;

East of a line formed by a projection of the westerly property limits of Lees Road; Ross Drive and Bayview Road, from Tower Drive southerly to Highway 17; and

North of Highway 17 between the westerly limit of Bayview Road easterly to the line formed by the boundary between the City of North Bay and the Township of East Ferris to the easterly corporate limits and then northerly to the northerly corporate limits and then westerly to the west corporate limits and then southerly to the westerly projection of the south limit of Cedar Heights Road, shown on the attached plan.
