BEING a By-Law of the Municipal Corporation of the City of North Bay to close that portion of McKay Avenue in the City of North Day in the District of Nipissing as shown on plan filed in the Office of Land Titles for the District of Nipissing as Plan M.234 and being more particularly described as being that portion of McKay Avenue lying South of the Southeasterly boundary of Trout Lake Road and North of the Northwesterly boundary of the one foot reserve lying adjacent to the Southeasterly boundary of said Plan M.234.

WHEREAS The Municipal Council of the Corporation of the City of North Bay have been requested, and upon consideration, deem it advisable to close part of an avenue running easterly in the City of North Bay in the District of Nipissing as said avenue is shown on Plan M.234 L.T.O., North Bay. Said avenue being more particularly described as follows:

That portion of McKay Avenue in the City of North Bay in the District of Nipissing as shown on plan filed in the Office of Land Titles for the District of Mipissing as Plan M.234 and being more particularly described as being that portion of McKay Avenue lying South of the Southeasterly boundary of Trout/Road and North of the Northwesterly boundary of the one foot reserve lying adjacent to the Southeasterly boundary of Said Plan 4.23 M.834.

THEREFORE UNDER AND BY VIRTUE OF THE AUTHORITY RESTORED IN THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY BY THE MUNICIPAL ACT, BEING R.S.O., 1950, CHAPTER 243, THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That portion of McKay Avenue in the City of North Bay in the District of Nipissing as shown on plan filed in the Office of Land Titles for the District of Nipissing as Plan M.234 and being more particularly described as being that portion of McKay Avenue lying South of the Southeasterly boundary of Trout Lake Road and North of the Northwesterly boundary of the one foot reserve lying adjacent to the Southeasterly boundary of said Plan M.234, and more particularly described as follows:

Commencing at the north-east angle of Lot 10 Plan M.234, thence southerly 265.66' along the easterly boundary of Lot 10 Plan M.234 (which is also the westerly boundary of McKay Avenue) to a point in the southeasterly boundary of lot 9 Plan M.234, thence northeasterly along the northwesterly boundary of the one foot reserve lying adjacent to the southeasterly boundary of the one foot reserve lying adjacent to the southeasterly boundary of Lot 11, Plan M.234, 82.18' to a point which is the southwesterly angle of Lot 11, Plan M.234, thence northerly along the westerly boundaries of Lots 11 and 12 Plan M.234, (which is also the easterly boundary of McKay Avenue) 320.70' to a point which is the northwesterly angle of Lot 12 Plan M.234, thence southwesterly 82.91' to the place of commencement, being part of parcel 2821 W & F, and the same is hereby closed and stopped up.

2. That forthwith upon this by-law taking effect the Council of the Municipal Corporation of the City of North Bay shall convey the said part of avenue as closed and stopped up in the next preceding section to the Director of the Veterans Land Act for the consideration of the sum of One Dollar (\$1.00) and full costs of this By-Law including advertising.

3. That the Council of the Municipal Corporation in the City of North Bay shall hear in person or by his or her solicitor, counsel or agent, any person who claims that his or her lands will be prejudicially affected by the by-law and who applies to be heard.

4. That this By-Law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in the behalf.
