

BY-LAW NUMBER 522

BEING a By-law to fix the Polling Places, appoint Deputy Returning Officers and Poll Clerks for the holding of the Municipal and Public School Trustees' Elections for the year 1918.

WHEREAS it is necessary to pass a By-law fixing Polling Places and appointing Deputy Returning Officers and Poll Clerks for the purpose of taking the vote of the Electors to select a Mayor and nine Councillors to transact the Municipal Affairs of the Town, and also for the election of Public School Trustees for the year 1918.

THEREFORE the Municipal Council of the Town of North Bay enacts as follows;-

1. THAT Polling Place No. 1 for the purpose of the said Election shall be in the House of T. H. Winters and T. H. Winters is hereby appointed Deputy Returning Officer, and John Miller is hereby appointed Poll Clerk at said Polling Place.
2. THAT Polling Place No. 2. for the purpose of the said Election shall be in the Court House and *R. J. Angus* is hereby appointed Deputy Returning Officer, and ~~G. E. Winters~~ *Don McKee* is hereby appointed Poll Clerk at said Polling Place.
3. THAT Polling Place No. 3. for the purpose of the said election shall be in Jas. Palangio's House 16 Front street, and S. J. Duhn is hereby appointed Deputy Returning Officer, and *E. Young* is hereby appointed Poll Clerk at the said polling place.
4. THAT Polling Place No. 4. for the purpose of the said election shall be in the Gas House and A. C. Amos is hereby appointed Deputy Returning Officer, and *J. M. Knechtel* is hereby appointed Poll Clerk at said Polling Place.
5. THAT Polling Place No. 5. for the purpose of the said election shall be in the Town Hall and N. Phelps is hereby appointed Deputy Returning Officer, and *H. C. Clarke* is hereby appointed Poll Clerk at said Polling Place.

6. THAT Polling Place No. 6. for the purpose of the said election shall be in Harry Atcheson's House, and A. O. Laing is hereby appointed Deputy Returning Officer, and Wm. Connell is hereby appointed Poll Clerk at said Polling Place.
7. THAT Polling Place No. 7 for the purpose of the said election shall be in the Orange Hall, and G. H. Newton is hereby appointed Deputy Returning Officer and ~~Paul Newton~~ <sup>Percy Biggs</sup> is hereby appointed Poll Clerk at said Polling Place.
8. THAT Polling Place No. 8. for the purpose of the said election shall be in Jas. H. Kennedy's house, and Fred Biggs is hereby appointed Deputy Returning Officer, and ~~Percy Biggs~~ <sup>Paul Newton</sup> is hereby appointed Poll Clerk at the said Polling Place.
9. THAT Polling Place No. 9, for the purpose of the said election shall be in ~~Paul Newton's~~ <sup>S. J. Gordon's</sup> house, and J. J. Pratt is hereby appointed Deputy Returning Officer, and J. J. Lyamen is hereby appointed Poll Clerk at the said Polling Place.
10. THAT Polling Place No. 10 for the purpose of the said election shall be in Ambrose Grieves' House, 478 Fisher street and John Richardson is hereby appointed Deputy Returning Officer and ~~C. S. McCaughey~~ <sup>C. S. McCaughey</sup> is hereby appointed Poll Clerk at the said Polling Place.
11. THAT Polling Place No. 11 for the purpose of the said election shall be in H. Burrow's Store Cassells st cor. Percy, and P. A. Conroy is hereby appointed Deputy Returning Officer, and ~~John M. Coleman~~ <sup>John M. Coleman</sup> is hereby appointed Poll Clerk at the said Polling Place.
12. THAT Polling Place No. 12 for the purpose of the said election shall be in Ed. Benoit's Place, Front st. corner Morin st, and D. J. McKeown is hereby appointed Deputy Returning Officer and ~~Dan McKeown~~ <sup>C. E. Mentore</sup> is hereby appointed Poll Clerk at the said Polling Place.

13. THAT Polling Place No. 13 for the purpose of the said Election shall be in E. C. Bebee's Store, Front street, and <sup>Geo. Morgan</sup> ~~W. E. Hicks~~ is hereby appointed Deputy Returning Officer, and <sup>E. C. Bebee</sup> is hereby appointed Poll Clerk at the said polling Place.
