

BY-LAW NO. 1894

BEING A BY-LAW of the Corporation of the City of North Bay regulating the closing of shops belonging to the class of Hairdressing Parlours.

WHEREAS a petition duly signed under the provisions of Section 83, subsection 4, of The Factory, Shop and Office Building Act, being Chapter 126 of the Revised Statutes of Ontario and Section 83, subsection (5A) of The Factory, Shop and Office Building Act, being Chapter 23 of the Statutes of the Province of Ontario, 1951, has been presented to the Council of the Corporation of The City of North Bay praying that a By-law be passed amending By-laws Number 1409 and 1161 and all amendments thereto, insofar as it affects the shops belonging to the class of Hairdressing Parlours.

AND WHEREAS it is deemed advisable to amend By-laws Number 1409 and 1161 and all amendments thereto in accordance with the petition as presented.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT all shops within the limits of the City of North Bay belonging to the class of Hairdressing Parlours shall be closed at the hour of six of the clock of the afternoon of each day in each week of the year, excepting Mondays and Thursdays, and the said shops shall remain closed from the said hour of six of the clock of the afternoon until five of the clock of the forenoon of the next following day.
2. THAT all of the said shops within the limits of the City of North Bay shall be closed on Monday of each week of the year during the whole of such day and the said shops shall remain closed until five of the clock of the forenoon of the next following day, (excepting the Mondays in the weeks in which Christmas Day and New Year's Day fall on a working day, whereupon the hours of closing on such Mondays so excepted shall be governed by the provisions of paragraph 1 above.)
3. THAT all of the said shops within the limits of the City of North Bay shall be closed on Thursday of each week of the year at the hour of nine of the clock of the afternoon and the said shops shall remain closed from the said hour of nine of the clock of the afternoon until five of the clock of the forenoon of the next following day.
4. THAT the provisions for closing during Monday shall not be affected by reason of the fact of a holiday in any week of the year excepting Christmas Day and New Year's Day as aforesaid.
5. THAT the provisions of By-laws Number 1161 and 1409 and all amendments thereto inconsistent with the provisions of this By-law be and the same are hereby repealed.
6. THAT every person who contravenes any of the provisions of this By-law, upon conviction thereof, shall forfeit and pay a penalty in the sum of \$25.00 for the first offence, \$50.00 for the second offence, \$100.00 for the third offence, and \$300.00 for each succeeding offence.
7. THAT this By-law shall come into force and take effect on the date of final passing thereof.
