

BY-LAW NO. 1849:

BEING A BY-LAW to reserve certain City owned lots, (lanes and streets) for use in conjunction with the Community Memorial Building.

WHEREAS it is deemed advisable to reserve such lots (lanes and streets) to be used as grounds and parking area for the said Community Memorial Building.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. That the lots (lanes and streets) as set out in Schedule "A" attached hereto and forming part of this By-law be the lots (lanes and streets) so reserved to be used in conjunction with the Community Memorial Building as grounds and parking area.
2. That By-law No. 1500 be amended by deleting therefrom the lots as set out in Schedule "A" attached hereto.
3. That this By-law shall become effective on the date of passing thereof.

LOTS DESCRIBED AS FOLLOWS:

- (1) Aubrey Street on the West side, lots 378 to 394 inclusive,
Registered Plan No. 93.
- (2) Chippewa Street on the East side, lots 419 to 435 inclusive,
Registered Plan No. 93.
- (3) Ferguson Street
 - (a) on the South side, lots 358 to 367 inclusive, Registered
Plan No. 93.
 - (b) on the North Side, lots 368 to 377 inclusive, Registered
Plan No. 93.
- (4) Fraser Street on the South side, lots 400 to 404 inclusive,
Registered Plan No. 93.

LANES DESCRIBED AS FOLLOWS:-

- (1) All lanes contained within that area of land, being Block
No. 295, within Plan No. 93, which area is bounded by
Fraser Street on the North, Ferguson Street on the South,
Aubrey Street on the East and Chippewa Street on the West.

STREETS DESCRIBED AS FOLLOWS:-

- (1) Ferguson Street. That portion lying between the East
boundary of Chippewa Street and the
West boundary of Aubrey Street.
 - (2) Aubrey Street. That portion lying between the northerly
boundary produced, of the lane, south of
and parallel to Fraser Street on the north, and the northerly
boundary produced, of the lane south of and parallel to
Ferguson Street on the south.
