

BY-LAW NO. 1050

BEING A BY-LAW to authorize the execution of a Water Supply Agreement between the Municipal Council of the Corporation of the City of North Bay and the Municipal Council of the Corporation of the Township of West Ferris.

WHEREAS it is deemed expedient to execute a Water Supply Agreement between the above described Municipal Councils providing for the supply of water by the Municipal Council of the Corporation of the City of North Bay to the Municipal Council of the Corporation of the Township of West Ferris and the remuneration therefore.


THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

THAT the Mayor and Clerk of the Corporation of the City of North Bay be empowered to execute on behalf of the Municipal Corporation of the City of North Bay an Agreement between this Corporation and the Municipal Corporation of the Township of West Ferris a copy of which Agreement is hereunto annexed.


THAT all By-Laws or parts of By-Laws inconsistent with the attached Agreement are hereby repealed.

THIS BY-LAW shall come into effect immediately upon the passing thereof.

THIS AGREEMENT made in triplicate this Thirty-First day of March, A. D. 1932.

BETWEEN:

THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY

hereinafter called the Party

OF THE FIRST PART

AND:

THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF WEST

FERRIS, hereinafter called the Party

OF THE SECOND PART

WHEREAS the Party of the First Part owns and maintains a water distribution plant and system within the City of North Bay extending to the boundary of the Municipality of West Ferris.

AND WHEREAS the Party of the Second Part is desirous of obtaining their total supply of water from the Party of the First Part for the purpose of supplying water users within the Municipality of West Ferris.

NOW THIS AGREEMENT WITNESSETH that the Party of the First Part agrees to furnish a supply of water from the extreme South Easterly limit of the Municipality of the City of North Bay for the purpose of the Party of the Second Part.

IT IS AGREED that this agreement shall be a final agreement between the parties hereto and that any former agreements of any description concerning the water supply between the parties hereto be and the same are hereby cancelled.

SUBJECT to the terms and conditions hereinafter set forth said supply of water shall be furnished for a period of Ten (10) years from the date hereof.

THE PARTY of the Second Part agrees to pay for water so furnished at the rate of Thirty-five Cents (35¢) per thousand gallons for the first two hundred thousand gallons (200,000) or fraction thereof in each month and thereafter at the rate of Twenty Cents (20¢) per thousand gallons (1000) or fraction thereof in each month. Said rates to be paid monthly subject to a discount of 10% if paid within ten (10) days after the rendering
