

BY-LAW NO. 2072

A BY-LAW to amend By-law No. 1971, being a by-law to authorize construction of asphalt road surfaces, and curbs and gutters where specified, on certain streets in the City of North Bay.

WHEREAS by Resolution No. 33 adopted by City Council on November 19th, 1962, authority was granted to amend said by-law 1971 by deleting from Schedule "A" thereof, item No. 1 in the amount of \$3,598.48.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT Schedule "A" of By-law No. 1971 be amended as follows:
 - (a) Item No. 1, which reads as follows, be deleted
"Cassells Street - From Main Street to Oak Street, 40 feet wide \$3,598.48"
 - (b) The total estimated cost be reduced to read \$127,764.74, instead of \$131,363.22.
2. THAT this by-law shall not become effective until approval has been secured from the Ontario Municipal Board under authority of the Local Improvement Act, being Chap. 223, Section 18, R.S.O. 1960.

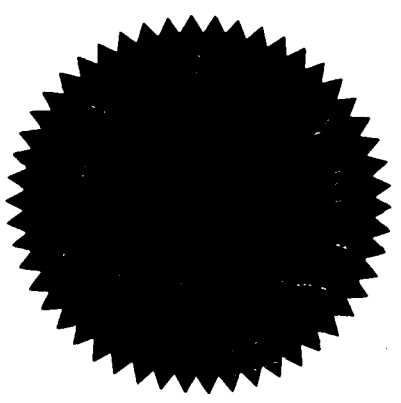

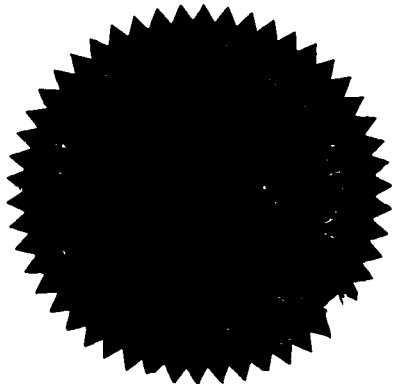
