BY-LAW NO. 2001-90

**BEING A BY-LAW TO AUTHORIZE THE INSTALLATION
OF UV DISINFECTION EQUIPMENT AT THE WATER
TREATMENT PLANT IN THE CITY OF NORTH BAY**

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45, Section 210, paragraph **58** authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45, Section 147(1) authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the Council passed Resolution No. 2001-438 at its meeting held July 9, 2001, approving the expenditure for installation of the UV Disinfection equipment;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. That the expenditure in the amount of \$2,000,000.00 for the supply and installation of UV disinfection equipment for the Water Treatment Facility as set out in Schedule "A" attached hereto and forming part of this by-law be hereby approved.
2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of purchase and installation as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount of \$2,000,000.00 limited in this by-law.
3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
4. That debentures to be issued when the work is completed to **pay** for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years on the instalment plan.

READ A SECOND TIME IN OPEN COUNCIL THIS 13TH DAY OF AUGUST, 2001.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 13TH DAY OF AUGUST. 2001.
