

THE BOARD ORDERS that the said application be and the same is hereby granted, and that the corporation may now proceed with the said undertaking at a total cost not to exceed \$93,000.00 and for such purpose may pass all requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$93,000.00, repayable over a term of not more than five years, and may borrow money to the extent sufficient to provide an amount not exceeding \$93,000.00 therefor, provided:

1. that the corporation may borrow the whole or any part of the said sum of \$93,000.00 as required pending receipt of subsidies and the sale of debentures or the receipt of moneys from any other source, and 2. that the amount to be debentured shall not exceed in any event the net cost to the corporation after deducting any grant or contribution from the Province of Ontario, or from any other source in respect of the said work.
