## CITY OF NORTH BAY

## By-law Number 1077

1011

A By-law to provide for borrowing the sum of \$55,800.00 upon debentures to pay the balance of the cost of certain extensions and improvements to the Waterworks System of the City of North Bay.

WHEREAS the Department of Health for Ontario by report in writing, dated the 25th day of June 1929, reported that it was of opinion that it was necessary in the interests of public health that certain extensions and improvements to the Waterworks System of the City of North Bay should be constructed;

AND WHEREAS it is necessary to borrow the sum of \$55,800.00, in addition to the amounts heretofore borrowed by the issue of debentures, to defray in full the cost of the said works and to issue debentures therefor, bearing interest at the rate of Six per cent. per annum, and the said sum of \$55,800.00 is the amount of the debt intended to be created by this by-law;

AND WHEREAS plans and specifications of the said works have been approved by the Department of Health for Ontario;

AND WHEREAS the amount of the whole rateable property of the Municipality, according to the last revised assessment roll, is § 9.945.092.00

AND WHEREAS the amount of the existing debenture debt of the Corporation, exclusive of local improvement debts secured by special rates or assessments, is \$ 1,201,325.36 and none of the principal or interest is in arrear; NOW THEREFORE the Municipal Council of the Corporation of the City of North Bay ENACTS AS FOLLOWS:

1. That for the purpose aforesaid there shall be borrowed on the credit of the Corporation at large the sum of \$55,800.00 and debentures shall be issued therefor in sums of not less than \$50.00 each, bearing interest at the rate of Six per cent. per annum, and having coupons attached thereto for the payment of interest, semi-annually.

2. The debentures shall all be dated as of the 1st day of September 1932 and shall be payable in twenty annual instalments on the 1st day of September in each of the years 1933 to 1952, inclusive, and the respective amounts of principal and interest payable in each of such years shall be as set forth in Schedule "A" hereto annexed.

3. The debentures as to both principal and interest shall be expressed in Canadian currency and may be payable at any place or places in Canada.

4. The Mayor of the Corporation shall sign and issue the debentures and the same shall also be signed by the Treasurer of the Corporation and shall be sealed with the seal of the Corporation. The coupons shall be signed by the Treasurer and his signature there on may be written, stamped, lithographed or engraved.

5. During twenty years, the currency of the debentures, the respective sums shown in Schedule "A" hereto shall be raised annually for the payment of the debt and interest by a special rate sufficient therefor over and above all other rates on all the rateable property in the Municipality at the same time and in the same manner as other rates.

6. The debentures may contain any clause providing for the registration thereof authorized by any Statute relating to
Municipal debentures in force at the time of the issue thereof.
7. This By-law shall take effect on the day of the final passing thereof.
