

BY-LAW NO. 1722

BEING A BY-LAW to levy the Taxes for the year 1954, and to provide for the collection thereof.

WHEREAS it is necessary and expedient to levy on the whole rateable property, according to the last revised Assessment Roll of the City of North Bay, a sum of money for the General Purposes of the City for the current year, and for the purposes of defraying of the expenses of the Public, Separate, Collegiate and Vocational School Education, Public Library, Direct Relief and other purposes.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. For the purpose of providing the sum of \$1,360,832.01 for the General Purpose of the Corporation, including the amount required for Public Separate, Collegiate & Vocational Schools, Public Library, Direct Relief, and other purposes for the current year, there shall be levied and collected a rate of 39.0 mills on the dollar upon the whole rateable property of the Public School Supporters of the City of North Bay according to the last revised Assessment Roll which rate is made up as follows:

and there shall be levied and collected during the said year a rate of 47.5 mills on the dollar upon the whole rateable property of the City of North Bay, of the Separate School Supporters according to the last revised Assessment Roll, which rate is made up as follows:

2. And it is hereby enacted that all taxes shall be paid into the Office of the Treasurer or the Collector of the City of North Bay.

3. The property taxes shall be payable in three instalments, one instalment of forty per cent (40%) shall be payable on the 17th day of May 1954, 30% on the 15th day of July 1954, and 30% on the 15th day of September 1954.

4. All business taxes shall be payable in one instalment on the 17th day of May 1954.

5. A penalty for non payment of taxes or any instalment thereof including both Business and Property Taxes of one half per centum shall be added on the first day of default, and every thirty days thereafter in which default continues, but not after the end of the year in which the taxes are levied, namely:

- (a) Taxes payable on the 17th day of May 1954 if paid after May 20th 1954, one half per centum shall be added on May 21st 1954, and one half per centum every thirty days in which default continues during 1954.
