AND FURTHER THAT a copy of this resolution be forwarded to Anthony Rota MP, Minister of Tourism Monique Smith, Minister of Industry and Trade Tony Clement, Minister of Energy and Infrastructure George Smitherman, Minister of Transport, Infrastructure and Communities John Baird, Federation of Northern Ontario Municipalities, Association of Municipalities of Ontario and the leaders of the Federal and Provincial oppositions.
