THEREFORE BE IT RESOLVED that the Council of the City of North Bay supports Blue Sky Economic Growth Corporation's application to all government Broadband funding programs that will seek to provide funding to SpectrumTelecom Group Ltd. to build a fibre and wireless access project in parts of the City of North Bay and South/East Region in the Districts of Nipissing and Parry Sound.
