THE CORPORATION OF THE CITY OF NORTH BAY BY-LAW NO. 2417

Being a By-law to license, regulate and govern persons whose names have not been entered on the Assessment Roll for The Corporation of the City of North Bay in respect of business assessment for the then current year and who offer goods, wares or merchandise for sale by auction conducted by themselves or by a licensed auctioneer, or who offer them for sale in any other manner;

And being a By-law requiring persons whose names are not entered on the Assessment Roll for The Corporation of the City of North Bay or are entered on it for the first time, in respect of business assessment, and who so offer goods, wares or merchandise for sale, to pay a license fee before commencing to trade.

WHEREAS The Municipal Act, R. S. O. 1960, Chapter 249, Section 401, Paragraphs 16 and 17 authorize the Council to pass By-laws for the purposes therein stated;

AND WHEREAS the Council of The Corporation of the City of North Bay deems it advisable to enact the within By-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The provisions of this By-law shall be applicable to and have full force and effect within the territorial limits of The Corporation of the City of North Bay.
- For the purposes of this By-law:
 - (a) "City" shall mean The Corporation of the City of North Bay;
 - (b) WCouncil" shall mean the Council of The Corporation of the City of North Bay;
 - (c) "Enforcement Officer" shall include the License Inspector and any member of the City Police Department;
 - (d) "License Inspector" shall mean the License Inspector for the time being of The Corporation of the City of North Bay;
 - (e) "Municipality" shall mean The Corporation of the City of North Bay;
 - (f) "Person" shall include firm, partnership, company, corporation, club or organization.

- 3. In the City of North Bay:
 - (a) No person whose name has not been entered on the Assessment Roll for the City in respect of business assessment for the then current year, shall offer goods, wares or merchandise for sale by auction, conducted by himself or by a licensed auctioneer or otherwise, or shall offer them for sale in any other manner without being licensed so to do under the provisions of this By-law;
 - (b) No person whose name is not entered on the Assessment Roll for the City or is entered on it for the first time, in respect of business assessment, shall offer goods, wares or merchandise for sale without being licensed so to do under the provisions of this By-law.
- 4. (a) The application for a license under this By-law shall be in writing on forms to be provided by the City and shall be fully completed and signed by the applicant.
 - (b) The aforesaid application shall contain the following information:
 - (i) A full description of the goods, wares or merchandise that the applicant proposes to sell or offer for sale under the license being applied for;
 - (ii) The full name, residence address, business address and telephone numbers of the applicant and each partner, if any;
 - (iii) If the applicant is a company, corporation, club or organization, the head office address, business address and telephone numbers as well as the full names, addresses and telephone numbers of the principal officers thereof;
 - (iv) The names, addresses and telephone numbers of the firms represented by the applicant;
 - (v) The names , addresses and telephone numbers of the manufacturers or suppliers of the goods, wares or merchandise intended to be sold;
 - (vi) The names, addresses and telephone numbers of three character references and three business references.
- The applicant, at the time of making application for license, shall furnish the License Inspector and the City Solicitor with true copies of all forms of contract, promissory notes or other documents intended to be used by the applicant in connection with his trade or business.
- 6. The License Inspector and the City Solicitor shall make all proper investigations pertaining to the applicant for a license as aforesaid and shall report thereon to Council when making their recommendations.

- 7. The applicant for a license under this By-law shall pay the prescribed license fee prior to the issue thereof.
- 8. A license issued pursuant to the provisions of this By-law shall be prominently and continuously displayed in the applicants place of business in the City during the period commencing from the date of the issue of such license until the expiration thereof.
- 9. Licenses under this By-law shall be issued by the License Inspector subject to the approval of Council.
- 10. Every person licensed under this By-law, upon changing his residence or business address, shall give written notice thereof to the License Inspector within ten (10) days after such change, setting forth his new address.
- 11. (a) Subject to the provisions of paragraph (b) hereof, the license fee payable pursuant to the provisions of this By-law is hereby fixed and set at the sum of \$250.00.
 - (b) The license fee payable by a farmer, resident in Ontario, who offers for sale only the produce of his own farm, is hereby fixed and set at the sum of \$5.00.
- 12. The provisions of this By-law shall be enforced by the Enforcement Officer.
- 13. The following provisions of The Municipal Act aforesaid shall be deemed to be incorporated in and form a part of this By-law:

Section 401, Paragraph 17

- (b) The by-law does not apply to the sale of the stock of a bankrupt or an insolvent, within the meaning of any bankruptcy or insolvency Act in force in Ontario, nor to the sale of any stock damaged by or by reason of fire, which is being sold or disposed of within the municipality in which the business was being carried on at the time of the bankruptcy, insolvency or fire, so long as no goods, wares or merchandise are added to such stock.
- (c) The by-law does not apply to the sale of a business to a bona fide purchaser who continues the business.
- (f) The sum paid for a license shall be credited to the person paying it, or to any bona fide purchaser of the business who carries on the business, on account of taxes payable in respect of the business, and in respect of real property taxes on the land used for the purposes of or in connection with the business if the land is owned by the person carrying on the business, during the year in which the license was issued and five years thereafter.

- 14. Any person convicted of a breach of any of the provisions of this By-law shall forfeit and pay, at theddiscretion of the convicting Magistrate, a fine or penalty not exceeding the sum of \$300.00 (Three Hundred Dollars) for each offence, exclusive of costs, to be recoverable under The Summary Convictions Act.
- 15. This By-law shall take effect upon the final passing thereof and shall remain in full force and effect from year to year until amended or repealed.
- 16. By-laws numbers 1200, 1600 and 2324 of The Corporation of the City of North Bay and all other By-laws or sections of By-laws of thesaid Corporation conflicting with the terms and provisions of this By-law shall be deemed to be and they are hereby repealed.
