BE IT THEREFORE RESOLVED THAT it is respectfully requested that the Province continue to ensure no new tax burden for Ontario residents and move exempt all single taxation items (for example: gasoline, natural gas, and electricity) from any new levies under the proposed HST;

AND BE IT FURTHER RESOLVED THAT the Province be urged to delay any implementation of the HST until full consultations are held across the Province and not just on Bay Street in Downtown Toronto;

AND BE IT FURTHER RESOLVED THAT that the Hon. Monique Smith, MPP Nipissing be requested to read this motion into the Legislature's Minutes;

AND BE IT FURTHER RESOLVED THAT a copy of this motion be forwarded to the Minister of Revenue; Minister of Finance; Premier of Ontario; Leaders of the Opposition Parties; Hon. Monique Smith, MPP for Nipissing and to the Federation of Northern Ontario Municipalities.
