BY-LAW NO. 71-91

A BY-LAW TO AMEND BY-LAW NO. 173-88 TO REGULATE PARKING ON MUNICIPAL PARKING LOTS

WHEREAS the Municipal Act, R.S.O. 1980, Chapter 302, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1980, Chapter 198, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

NOW THEREFORE THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Section 18 of By-law 173-88 is hereby deleted and the following section 18 inserted in lieu thereof:
 - "18. (1) Any person who contravenes any provision of this by-law is guilty of an offence and is subject to a fine recoverable under the Provincial Offences Act.
 - (2) Voluntary payment of a parking infraction notice according to the amounts set out on Schedule 20 in strict compliance with the conditions set out on the parking infraction notice shall be in lieu of any penalty otherwise provided by law.
 - (3) The owner of a motor vehicle is liable to the penalty provided for in this section to the same extent as the driver of such motor vehicle unless at the time of the offence the vehicle was in the possession of some person other than the owner, without the owner's consent."
- This by-law shall come into effect as of the date of the order of the Chief Judge of the Ontario Court of Justice (Provincial Division) to establish the set fines for the offences set out on Schedule "A".
