THE CORPORATION OF THE CITY OF NORTH BAY BY-LAW NO. 113-75

BEING A BY-LAW TO AMEND BY-LAW NO. 907 OF THE FORMER TOWNSHIP OF WEST FERRIS PURSUANT TO SECTION 35 OF THE PLANNING ACT, R.S.O. 1970, CHAPTER 349 AND AMEND-MENTS THERETO.

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-law No. 907 of the former Township of West Ferris to provide for a change in the zone designation shown on Schedule "B" which forms part of the said By-law No. 907.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Schedule "B" of By-law No. 907 of the former

 Township of West Ferris is amended by changing
 the zoning designation of the land shown on that
 part of said zoning map set out in Schedule "A"
 attached hereto and forming part hereof, which
 property is more particularly described as part
 of NR-81 Part 1 Parcel 7273 W&F shown as hatched
 on Schedule "B" attached hereto and forming part
 hereof from a "Rural (A) Zone" to an "Industrial
 (I) Zone".
- 2. This By-law shall take effect from the date of passing by Council and shall come into force upon the approval of the Ontario Municipal Board.


