BEING A BY-LAW ... amend By-law No. 1446, a By-law known as the Zoning By-law, and amendments thereto.

WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1446 with particular reference to amending By-laws Numbered 1456, 1601, 1604 and 1612.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. That the lands more particularly described in Schedule A attached hereto and forming part of this By-law be deleted from Schedule A of the said By-law and added to Schedule B.
- 2. That the lands more particularly described in Schedule B attached hereto and forming part of this By-law be deleted from Schedule B of the said By-law and added to Schedule A.
- 3. That the lands more particularly described in Schedule C attached hereto and forming part of this By-law be deleted from Schedule C of the said By-law and added to Schedule D.
- 4. That the lands more particularly described in Schedule D attached hereto and forming part of this By-law be deleted from Schedule C of the said By-law and added to Schedule E.
- 5. That the lands more particularly described in Schedule E attached hereto and forming part of this By-law, being part of Registered Plan No. 88 annexed by the City of North Bay on order of the Ontario Municipal Board and representing an area formerly within the Township of Widdifield and which was not previously classified be added to the appropriate schedules of By-law 1456 as indicated in Schedule E of this By-law.
- 6. That the lands more particularly described in Schedule F attached hereto and forming part of this By-law, being the lands within Registered Plans 110, 113, 114 and 115 annexed by the City of North Bay on order of the Ontario Municipal Board and representing an area formerly within the Township of Widdifield and which was not previously classified be added to the appropriate schedules of By-law 1456 as indicated in Schedule F of this By-law.
- 7. That By-law 1601 as amended by By-laws 1604 and 1612 be repealed and that all the lands within the area of the plan to expunge lots 39 to 150 incl., lots 297 to 306 incl., lots 317, 318, 319, and North 18 ft. of lot 320, lots 324 to 379 incl., lots 381 to 384 incl., 388 to 391 incl., lots 395 to 404 incl., lots 415, 416, and 417 and the North 26 ft. of lot 418 together with those parts of certain streets and lanes adjoining the said lots as shown on Registered Plan 78 and which area is now represented as lots 1 to 109 Registered Plan 112, be deleted from Schedules A, B and D of By-law 1456 and added to Schedule B of By-law 1456.
- 8. That this By-law shall come into effect upon receipt of approval in writing by the Minister of Planning and Development and the Ontario Municipal Board, thereby amending the Zoning By-law and Official Plan of the City of North Bay.


