BY-LAW NO. 105-91

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 57-89 (SCHEDULE 2 - NO PARKING ANYTIME; SCHEDULE 17 - TRAFFIC CONTROL SIGNALS)
