AND WHEREAS the proposed legislation adds requirements to notice provisions, open meetings, minutes, forms of meetings, among other matters all of which are addressed in the *Municipal Act*, which would create confusion for council, administration and the public;

AND WHEREAS the *Municipal Act* is currently under review and is being informed by input from the municipal and private sectors among others;

AND WHEREAS the Association of Municipalities of Ontario and others have urged the Standing Committee to remove any reference to municipal councils or council committees from this legislation and allow transparency and accountability issues to continue to be regulated under the *Municipal Act*:

THEREFORE BE IT RESOLVED THAT the City of North Bay urges the Minister of Municipal Affairs and Housing to vote against the Bill if the reference to 'municipal councils' is not deleted in the Bill as reported by the Standing Committee;

AND FURTHER THAT Monique Smith, MPP Nipissing and all provincial members of the legislature be advised of the lack of this council's support for the inclusion of 'municipal councils' in Bill 123.

AND WHEREAS the Forestry Industry is the number one industry in Northern Ontario and one of the largest in Ontario generating \$19 billion in annual sales, employing directly and indirectly 275,000 people, paying direct sales of \$4.8 billion a year;

AND WHEREAS Tembec alone has a payroll of over 11,000 employees in Canada;

AND WHEREAS 3,500 of these employees are employed in North Eastern Ontario and over 8,000 across Canada, and is one of the largest Industrial employers to North Bay;

AND WHEREAS the total economic benefit of this Industry to our region is estimated to be 65 million;

AND WHEREAS the ongoing Softwood lumber dispute has cost Canadian lumber manufacturers hundreds of millions of dollars with Tembec alone paying \$300 million in illegal tariffs just in the last three (3) years;

AND WHEREAS the custom duties, rates of exchange and increases in energy costs have put the Industry in Canada to a real disadvantage with losses to the company in the estimates of \$I billion of working capital;

AND WHEREAS the North American Free Trade Agreement (NAFTA) Extraordinary Challenge Committee (ECC) clearly and unanimously ruled that Canada does not subsidize the forestry sector or pose any threat to the United States (U.S.) Trade Law;

AND WHEREAS continued illegal imposition of duties and tariffs on Canadian Softwood have contributed to the loss of Canadian and Ontario forestry sector jobs;

AND WHEREAS these tariffs threaten more job losses and closures of plants if the wait for settlements in Court lingers on for another two years. Ontario Lumber Producers simply cannot wait any longer. The Industry needs support NOW.

THEREFORE BE IT RESOLVED THAT the City of North Bay supports immediate and full implementation of a Loan Guarantee Program for the forestry sector by the Government of Canada to provide softwood lumber producing companies with loan guarantees to offset the cost of illegally imposed U.S. duties and tariffs that put no risk to taxpayers and to act upon this NOW;

AND FURTHER THAT the Canadian Government send a clear message to the U.S. that Canada:

- 1) supports the legally recognized position of Canada's softwood lumber producers;
- 2) supports the fundamental tenets of the North American Free Trade Agreement;
- 3) supports the trade rights of all Canadians and Canadian Companies exporting to the United States

AND FURTHER BE IT RESOLVED THAT this motion be forwarded to the Office of the Prime Minister, Paul Martin; MP Anthony Rota and MPP Monique Smith;

AND FURTHER THAT the City send a copy of this resolution to the Association of Municipalities of Ontario, with the request that the resolution be forwarded to other municipalities across the Province requesting their support.
