SCHEDULE "K"

Subject to the regulations contained in Schedule "J", Parts A, B, C & D to By-law No. 1896 of the Corporation of the City of North Bay, as amended, the fee for parking at a parking meter is hereby established as follows:

(a) Two nickels or one dime for each thirty minutes or fraction thereof and four nickels or two dimes for each sixty minutes or fraction thereof in excess of thirty minutes for parking at a parking meter located in the following parking meter zones:

McIntyre Street	Both Sides	Wyld Street	Cassells St.
Main Street	Both Sides	Sherbrooke St.	Cassells St.
Oak Street	Both Sides	Wyld Street	Fraser St.

(b) One nickel for each thirty minutes or fraction thereof and two nickels or one dime for each sixty minutes or fraction thereof in excess of thirty minutes for parking at a parking meter in all parking meter zones other than those set out in clause (a) of this Schedule.

Such parking fee shall be payable between and during the hours of 8:00 a.m. and 6:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday and Saturday of each week.

No parking fee shall be payable on a holiday as hereinbefore defined.
