BY-LAW NUMBER 936

BEING a BY-LAW of the Corporation of the City of North Bay closing certain lanes within the said Corporation.

WHEREAS the Municipal Corporation of the City of North Bay deems it advisable to close certain lanes within the City of North Bay and to sell and convey the same.

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS: -

THAT the following lanes in the City of North Bay be and the hereby closed and stopped up.

FROM the North Easterly side of Second Avenue North Easterly ce of One Hundred and Thirty-seven (137 ft.) feet.

FROM the North Westerly limits of Lots number 10 and 18 South Easterly a distance of One Hundred and Seventy-four (174 Ft.) feet.

The portion of the said lanes to be closed and stopped up herein being more particularly described in Schedule "A" hereunto annexed.

THAT the said Council shall hear in person or by his or her counsel, solicitor or agent any person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.

THAT forthwith upon this By-Law taking effect the Corporation of the City of North Bay shall convey to the Canadian National Railway Company for the consideration of the sum of \$1.00, those portions of the said lanes closed and stopped up under the provisions herein, subject to payment by the Canadian National Railway of any damages that may be prejudicially effected by the closing of said lane or lanes.

THAT this By-Law shall take effect after a notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.

SCHEDULE "A"

THIS is Schedule "A" referred to in By-Law Number 936 of the City of North Bay.

PARCEL "A". THAT portion of the lane between Lot Number 23, on the North Easterly side of Second Avenue and Lots Number 27, 28, 29, 30, and 31, on the North Westerly side of Sherbrooke Street, and being of a uniform width of Ten feet 10Ft. and extending from the North Easterly boundary of Second Avenue in a North Easterly direction, a distance of One Hundred and Thirty-seven (137 Ft.) feet.

PARCEL "B". THAT portion of the lane between Lots Number 10, 11, 12, 13, 14, and 15 on the South Westerly side of Third Avenue, and Lots Number 18, 19, 20, 21, 22, and 23, on the North Easterly side of Second Avenue, and being of a uniform width of Ten (10 ft.) feet and extending from the projected North Westerly boundaries of said lots Number 10 and 18 on the South Westerly side of Third Avenue and the North Easterly side of Second Avenue respectively between the above mentioned lots in a South Easterly direction a distance of One Hundred and Seventyfour (174 ft) feet.
