THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 66-92

BEING A BY-LAW TO STOP UP, CLOSE AND SELL AN ORIGINAL LAKESHORE ROAD ALLOWANCE ALONG TROUT LAKE.

WHEREAS the Council of The Corporation of the City of North Bay deems it desirable to close up and sell part of an original Lakeshore Road Allowance along the shores of Trout Lake;

AND WHEREAS Section 298(1) of the Municipal Act, R.S.O., 1980, Chapter 302, authorizes the Council to pass By-Laws to stop up and sell the freehold of a highway, provided that the By-Law does not take effect until it has been approved by the Minister of Municipal Affairs and Housing;

AND WHEREAS notice of this By-Law has been published at least once a week for four successive weeks and the Council has heard any person who claims that his or her land will be prejudicially affected by this By-Law and who has applied to be heard.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. To close, stop up and sell parts of the original road allowance laid out in front of Lot 25, Concession 17, of the Municipality of the City of North Bay, District of Nipissing, being designated as Parts 2, 4, 6, 8, 10 and 11, according to Plan 36R-8762.
- 2. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of those parts of the original lakeshore road allowance designated as Parts 2 and 11 on the said Reference Plan to William Peter Butler, David Gordon Butler, Geraldine F. Neily and Orma L. Foster, registered owners of Parcel 1884, W/F.
- 3. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the original lakeshore road allowance designated as Part 4, on the said Reference Plan to Gail Elizabeth Clark, registered owner of Parcel 1883, W/F.
- 4. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the original lakeshore road allowance designated as Part 6, on the said Reference Plan to Gordon Tullis Ross and Inez Elizabeth Ross, the registered owners of Parcel 1882, W/F.
- 5. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the original lakeshore road allowance designated as Part 8 on the said Reference Plan to Orma L. Foster, the registered owner of Parcel 1881, W/F.
- 6. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the original lakeshore road allowance designated as Part 10 on the said Reference Plan to Geraldine F. Neily, the registered owner of Remainder of Parcel 252, W/F.

- 7. The Mayor and Clerk are hereby authorized and directed to execute a transfer in favour of the registered owners of land as referred to in Section 2, 3, 4, 5 and 6 of this By-Law.
- 8. This By-Law does not take effect until it has been approved by the Minister of Municipal Affairs and Housing.
