BY-LAW NO. 1996

BEING A BY-LAW of the Corporation of the City of North Bay to provide for the submission of a certain question for the assent of the electors qualified to vote on Money By-laws, and to appoint a day on which to take a vote thereon, and to name the places where votes are to be taken, and to appoint Deputy Returning Officers to take the vote at each such place.

WHEREAS the said Council deems it advisable to submit to the vote of the electors of the Corporation, qualified to vote on Money By-laws, the following question:-

"Are you in favour of authorizing the construction of an extension to the Civic Hospital to provide additional bed accommodation as follows:-

55 active treatment, 40 chronic, 8 post anaesthetic, 2 emergency and 5 additional beds (equivalent of 15 bassinets), at an estimated cost to the City of North Bay of \$1,519,447.16 net, after deducting Federal and Provincial grants? "

NOW THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTSAS FOLLOWS:-

1. THAT there shall be submitted to the electors of the City of North Bay, qualified to vote on Money By-laws, the following question:-

"Are you infavour of authorizing the construction of an extension to the Civic Hospital to provide additional bed accommodation as follows:-

55 active treatment, 40 chronic, 8 post anaesthetic, 2 emergency and 5 additional beds (equivalent of 15 bassinets), at an estimated cost to the City of North Bay of \$1,519,447.16 net, after deducting Federal and Provincial grants? "

- 2. THAT the vote of the said electors qualified to vote on Money By-laws shall be taken on the said question at the same time and places and by the same Deputy Returning Officers and Poll Clerks, as the Annual Municipal Election.
- 3. THAT a true copy of the question shall be published in the North Bay Daily Nugget on the days hereinafter Mentioned, that is to say on the Sixteenth, Twenty-third and Thirtieth days of November, 1961.
- 4. THAT on the Twenty-fourth day of November at his office, at the hour of 2:00 o'clock in the afternoon, the Council Chambers on McIntyre Street, the Mayor will, in writing, signed by him, appoint two persons to attend the final summing up of the votes by the Clerk of the Corporation and one person to attend each Polling Place on behalf of the persons interested in and desirous of promoting the acceptance of the said question, and a like number on behalf of the persons interested in and desirous of the rejecton of the said question.

5. THAT the thirteenth day of December at the said Council Chambers at 12 o'clock noon is hereby appointed as the time and place for summing up by the Clerk of the Corporation of the number of votes given in the affirmative and in the negative, respectively.
