

BY-LAW NUMBER 1056

SCHEDULE "A" referred to in By-Law to widen Harriett Street from Rock Street to Robert Street as part of The West End Entrance.

DESCRIPTION OF LANDS

To be acquired for Western Entrance to the City of North Bay, Ont. All and singular those certain parcels or tracts of land and premises situated, lying and being in the City of North Bay, in the District of Nipissing and Province of Ontario being composed of Part of Lot 1, 2, 3, 4 and 5, on Harriett Street, plan by John H. Shaw, O.L.S. registered in the Registry Office Sept. 3rd, 1904, and which said parts of Lots may be more particularly described as follows:-

PART OF LOT #1 Commencing at a point, in the south-easterly limit of said Lot #1, being the corner of Harriett Street and Stevens (Formerly John) Street, thence north-easterly along the westerly side of Stevens Street, twenty-four feet five inches (24'5"), thence north-westerly sixty-six feet and one half inch (66' 1/2") to a point on line between Lots #1 and 2 said point being twenty-two feet (22'0") north easterly from the south westerly angle of Lot 1 thence south westerly twenty-two feet (22'0") along line between lots 1 and 2 to the north east side of Harriett Street thence south easterly along the north east side of Harriett Street sixty-six feet (66' 0") to the point of beginning.

PART OF LOT #2 Commencing at a point in the south easterly limit of said Lot #2 said point being on the north east side of Harriett Street on line between Lots #1 and #2, thence north easterly along said line twenty-two feet (22'0") thence north westerly sixty-six feet one inch (66' 1") to a point on the line between Lots #2 and 3 said point being eighteen feet (18'0") north easterly from the south westerly angle of Lot #2, thence south westerly eighteen feet (18' 0") along line between lots 2 and 3 to the north east side of Harriett Street thence south easterly along the north east side of Harriett Street Sixty-six feet (66') to the point of beginning.

PART OF EAST 1/2 OF LOT #3 Commencing at a point in the south easterly limits of said East half of Lot #3 said point being on the north east side of Harriett Street on line between lots #2 and the east half of Lot #3. Thence north easterly along said line eighteen feet (18') thence north westerly thirty-three feet one and one-half inches (33'1 1/2") to a point on the line between the east half and west half of Lot #3 said point being fifteen feet one and one-half inches (15'1 1/2") north easterly from the south westerly angle of the east half of Lot #3 thence south westerly fifteen feet one and one half inches (15'1 1/2") along said line to the north east side of Harriett Street thence southeasterly along North East side of Harriett Street, thirty-three feet (33') to the place of beginning.

PART OF WEST 1/2 OF LOT # 3 Commencing at a point in the south easterly limit of said west half of Lot #3 said point being on the North east side of Harriett Street on line between the east half and west half of Lot #3 thence north Easterly along said line fifteen feet one and one half inch (15'1 1/2") thence north westerly thirty three feet one and one-half inch (33'1 1/2") to a point on the line between the west half of Lot #3 and Lot #4, said point being twelve feet three inches (12'3") north easterly from the south westerly angle of the west half of Lot #3 thence south westerly twelve feet three inches (12'3") along said line to the North East side of Harriett Street thence south easterly along the north east side of Harriett Street, thirty-three feet (33') to the point of beginning.

PART OF LOT #4 Commencing at a point in the south easterly limit of Lot #4 said point being on the north east side of Harriett Street on line between lot 4 and west half of Lot #3, thence north easterly twelve feet three inches (12'3") along said line, thence north westerly sixty-six feet five inches (66'5") to a point on the line between lots 4 and 5 said point being five feet one inch (5'1") north easterly from the south westerly angle of Lot #4 thence south westerly five feet one inch (5'1") along said line to the north east side of Harriett Street, thence south easterly along the north East side of Harriett Street, sixty-six feet (66'0") to the point of beginning.

PART OF LOT #5 Commencing at a point in the south easterly limit of Lot #5 said point being on the north east side of Harriett Street on the line between Lots #4 and 5 thence north easterly five feet and one inch (5'1") along said line, thence north westerly sixty-six feet six and one half inches (66'6½") to a point at the intersection of the line between lots 5 and 6, and the north east side of Harriett Street thence south easterly along the north east side of Harriett Street sixty-six feet two inches (66'2") to the point of beginning.

PART OF BLOCK Y According to a plan of sub-division prepared by Wm. Bell P.L.S. and registered in the Registry Office for the said District July 17th. 1886, and which said part of Block Y may be more particularly described as follows:--

Commencing at a point in the south westerly limits of the said Block Y, thence south easterly one hundred and ninety-eight (198') along the north east side of Harriett Street, thence north easterly twenty-six feet five inches (26'5") along a line parallel to the westerly side of Block Y, thence north westerly and parallel with the south westerly limits One Hundred and ninety-eight feet (198'0") to the easterly side of Stevens Street (formerly John Street) thence south westerly twenty-six feet five inches (26'5") to the place of beginning.
