## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 71-95

## BEING A BY-LAW TO PROVIDE FOR THE LEVYING OF A TAX FOR THE YEAR 1995 UPON THE NORTH BAY CIVIC HOSPITAL, NORTH BAY PSYCHIATRIC HOSPITAL, ST. JOSEPH'S GENERAL HOSPITAL, NIPISSING UNIVERSITY, CANADORE COLLEGE, AND NORTH BAY DISTRICT JAIL.

WHEREAS pursuant to Section 157 of the Municipal Act and other authorizing statutes there is hereby levied in 1995 an annual tax upon the following institutions:

North Bay Civic Hospital North Bay Psychiatric Hospital St. Joseph's General Hospital Nipissing University Canadore College North Bay District Jail

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. (a) Upon the North Bay Civic Hospital a tax of \$15,825.00 being \$75.00 for each Provincially-rated bed based on a capacity of 211 in that hospital as determined by the Minister of Health;
  - (b) Upon the North Bay Psychiatric Hospital a tax of \$20,400.00 being \$75.00 for each Provincially-rated bed based on a capacity of 272 in that hospital as determined by the Minister of Health;
  - (c) Upon the St. Joseph's General Hospital a tax of \$12,825.00 being \$75.00 for each Provincially-rated bed based on a capacity of 171 in that hospital as determined by the Minister of Health;
  - (d) Upon the Nipissing University a tax of \$105,900.00 being \$75.00 for each full time student based on a capacity of 1,412 as determined by the Minister of Colleges and Universities;
  - (e) Upon the Canadore College a tax of \$242,250.00 being \$75.00 for each full time student based on a capacity of 3,230 as determined by the Minister of Colleges and Universities;
  - (f) Upon the North Bay District Jail a tax of \$7,350.00 being \$75.00 for each resident place based on a capacity of 98 as determined by the Minister of Correctional Services.

2. The amounts levied under this By-law shall become due and payable in full on the 1st day of July, 1995.
