The General Government Committee presents Report No. 2017-06 and recommends:

- 1. That The Corporation of the City of North Bay continues to support the redevelopment of Cassellholme East Nipissing District Home for the Aged (Cassellholme); and
- 2. That The Corporation of the City of North Bay supports the request for legislative changes to allow Cassellholme Board of Management to borrow the necessary funds, on its own, to complete the redevelopment project and repay the debt using a combination of Capital Subsidy payments by the Ministry of Health and Long-Term Care as well as revenue from operations and annual levy to the municipalities in proportion; and
- 3.
