BY-LAW NUMBER 893

BEING A BY-LAW of the Corporation of the City of North Bay closing certain streets and lanes within the said Corporation.

WHEREAS the Municipal Corporation of the City of North Bay deems it advisable to close certain streets within the City of North Bay and to sell and convey the same.

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

THAT the following streets and lanes in the City of North Bay be and the same are hereby closed and stopped up.

The portion of said streets and lanes to be closed and stopped up herein being more particularly described in Schedule "4" hereunto annexed.

That the said Council shall hear in person by his or her counsel, Solicitor or Agent iny person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.

THAT forthwith upon this By-Law taking effect the Corporation of the City of North Bay shall convey to the Board of Governors of the Home for the Aged, for the consideration of \$1.00 all the portions of said streets and lanes closed and stopped up under the Provisions hereof.

THAT this By-Law shall take effect after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in this behalf.


