THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2369

Being a By-law passed pursuant to the provisions of The Local Improvement Act R.S.O. 1960, Chapter 223, Section 8 declaring it is necessary and desirable to replace the sidewalks in the City of North Bay as specified and described in Schedule "A" to this By-law at the expense of The Corporation of the City of North Bay in accordance with The Local Improvement Act aforesaid, Section 59(1).

WHEREAS the sidewalks more particularly specified and described in Schedule "A" to this By-law need to be replaced;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Pursuant to the provisions of The Local Improvement Act, R. S. O. 1960, Chapter 223, Section 8, it is hereby declared to be necessary and desirable that the sidewalks more particularly specified and described in Schedule "A" attached hereto (and which said Schedule "A" shall be deemed to be incorporated in and form part of this By-law) be replaced at the expense of The Corporation of the City of North Bay pursuant to the provisions of The Local Improvement Act aforesaid Section 59(1).
2. That a By-law be enacted for the issue of debentures to cover the cost of the aforesaid replacement of sidewalks.
3. This By-law will take effect upon the final passing thereof and upon receiving the approval of the Ontario Municipal Board.
