BY-LAW NO. 89-79

BEING A BY-LAW TO AMEND BY-LAW NUMBER
90-76 OF THE CITY OF NORTH BAY

WHEREAS the Municipal Act, R.S.O. 1970, Ch. 284,
Section 354(1), Paragraph 53 authorizes the Council to pass
a by-law for the purposes therein stated;

AND WHEREAS it is deemed expedient to amend
By-law Number 90-76 of the City of North Bay;

AND WHEREAS this by-law is passed with the approval
of the Ontario Municipal Board.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH
BAY HEREBY ENACTS AS FOLLOWS:

1. That By-law Number 90-76 be amended by deleting
Schedule "A" attached thereto and inserting
Schedule "A" attached and forming part of this
by-law in lieu thereof.

THIS 11th DAY OF JUNE , 1979.

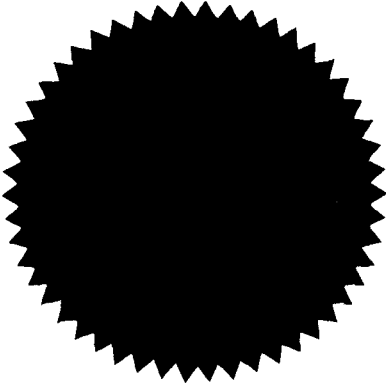
